**ARTICLES OF INCORPORATION
OF
THE ELITE DVBE NETWORK**

I

The name of the existing unincorporated association now being incorporated by the filing of these articles is
THE ELITE DVBE NETWORK.

II

This corporation is a nonprofit mutual benefit corporation organized under the Nonprofit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity, other than credit union business, for which a corporation may be organized under such law. The purposes, without limitation, for which this corporation is organized are as follows:

- A. Promoting the social welfare of the community,
- B. Assisting needy and disabled veterans, widows, or orphans of deceased veterans,
- B. Providing entertainment, care and assistance to hospitalized veterans or members of the Armed Forces of the United States,
- C. Perpetuating the memory of Veterans and comforting their survivors,
- D. Conducting programs for religious, charitable, scientific, literary, or educational purposes,
- E. Sponsoring or participating in patriotic activities,
- F. Providing insurance benefits to members or member's dependents, or
- G. Providing social and recreational activities for members.

Further, the specific purposes of this organization , without limitation, for which this organization is are as follows:

- 1) To provide a disabled veteran's forum to discuss and take action to advance the common interests of disabled veterans;
- 2) To provide education and information concerning disabled veterans businesses and enterprises and governmental programs and legislation for disabled veterans;
- 3) To provide services for the benefit of disabled veterans and disabled veteran businesses and enterprises;
- 4) To advance the economic interests of disabled veterans;
- 5) To bring about the increased quality of life and economic well being of disabled veterans;

This corporation is organized and operated exclusively for purposes within the meaning of Section 501 (c) (19), Internal Revenue Code. Despite any other provision of these articles, this corporation shall not , except to an insubstantial degree, engage in any activity or exercise any powers that do not further the purposes of this corporation .

VI



month after the end of your annual accounting period. A penalty of \$20 a day is charged when a return is filed late, unless there is reasonable cause for the delay. However, the maximum penalty charged cannot exceed \$10,000 or 5 percent of your gross receipts for the year, whichever is less. For organizations with gross receipts exceeding \$1,000,000 in any year, the penalty is \$100 per day per return, unless there is reasonable cause for the delay. The maximum penalty for an organization with gross receipts exceeding \$1,000,000 shall not exceed \$50,000. This penalty may also be charged if a return is not complete, so please be sure your return is complete before you file it.

You are not required to file Federal income tax returns unless you are subject to the tax on unrelated business income under section 511 of the Code. If you are subject to this tax, you must file an income tax return on Form 990-T, Exempt Organization Business Income Tax Return. In this letter we are not determining whether any of your present or proposed activities are unrelated trade or business as defined in section 513 of the Code.

You are required to make your annual information return, Form 990 or Form 990-EZ, available for public inspection for three years after the later of the due date of the return or the date the return is filed. You need an employer identification number even if you have no employees. If an employer identification number was not entered on your application, a number will be assigned to you and you will be advised of it. Please use that number on all returns you file and in all correspondence with the Internal Revenue Service.

This ruling/determination is based on your representation that at least 75 percent of your members are past or present members of the Armed Forces of the United States defined under section 501(c)(19) of the Code. It is also based on your representation that substantially all of your other members, if any, are individuals who are cadets, or are spouses, widows, or widowers of past or present members of the Armed Forces of the United States or of cadets.

Based on your representation that at least 90 percent of your members are war veterans and that you are organized and operated primarily for purposes consistent with your current status as a war veterans organization, donors can deduct contributions made to or for the use of your organization.

If, in the future, your organization does not meet this membership test or if your purposes, character, or method of operation changes, donors cannot



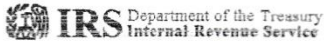

Dear Taxpayer:

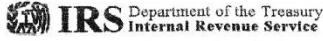
