For urganizations with gross receipts exceeding \$1,000,090 in any year, the genalty is \$100 per day per return, unless there is reasonable cause for the délay. The maximum penalty for an organization with gross fereipts exceeding \$1,000,000 shall not exceed \$50,000. This penalty may also be charged if a return is not complete, so please be sure your return is complete before you tile it.
